## WHAT IS THIS PRODUCT?

Type: This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities

(UCITS).

Term: This product has no maturity date. However, the Board of Directors may decide to close the product under certain circumstances.

Objectives:

The Sub-Fund aims to generate excess returns against the designated benchmark TOPIX Total Return Index on a consistent basis,

measured in JPY. The Sub-Fund promotes environmental and social characteristics by applying environmental, social and governance (or ESG) criteria to the portfolio, pursuant to Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector (the "SFDR"). The investment objective is pursued through investing at least two thirds of the assets in a high conviction concentrated portfolio of equities or equity related securities which are listed or traded on recognised exchanges in Japan, with a high return potential. Sakigake means pioneer or leader in Japanese. The Investment Manager aims to achieve the investment objective by identifying long-term investment themes and Sakigake stocks which fall into each theme through fundamental research.

The Sub-Fund is actively managed. The Sub-Fund is managed in reference to the TOPIX Total Return Index (the "Benchmark") for the purposes of performance measurement, in particular for outperformance and marketing purposes. The Sub-Fund's portfolio may replicate fully or partially from time to time the components of the Benchmark.

Distribution Policy: Your units will be non-distributing. Income from investments in the Sub-Fund will be re-invested and therefore rolled up into the value of your units.

The Sub-Fund launched on 31 May 2018. The Share Class launched on 29 October 2021.

The currency of the Fund is JPY, the currency of this product is USD.


Intended retail investor:

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

The risk indicator assumes you keep the product for 5 years The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Investors shall note that besides the risks included in the risk indicator, other risks such as Liquidity, Counterparty, Currency, Investment risk (which is concentrated in specific sectors), the value of equities and equity-related securities, Concentration Risk and Hedging risk may affect the Fund's performance.

However, investors may suffer a loss if the Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

# WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

#### Cost over time

The tables below show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- •In the first year you would get back the amount that you invested (0% annual return).

## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

The recommended minimum holding period: 5 years.
