WHAT IS THIS PRODUCT?

Type: This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities

(UCITS).

The Sub-Fund aims to generate excess returns against the designated benchmark TOPIX Total Return Index on a consistent basis, measured in JPY. The Sub-Fund promotes environmental and social characteristics by applying environmental, social and governance (or ESG) criteria to the portfolio, pursuant to Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector (the "SFDR"). The investment objective is pursued through investing at least two thirds of the assets in a high conviction concentrated portfolio of equities or equity related securities which are listed or traded on recognised exchanges in Japan, with a high return potential. The Investment Manager aims to achieve the investment objective by identifying long-term investment themes and Sakigake stocks which fall into each theme through fundamental research.

The Sub-Fund is actively managed. The Sub-Fund is managed in reference to the TOPIX Total Return Index (the "Benchmark") for the purposes of performance measurement, in particular for outperformance and marketing purposes. The Sub-Fund's portfolio may replicate fully or partially from time to time the components of the Benchmark.

Distribution Policy: Your units will be non-distributing. Income from investments in the Sub-Fund will be re-invested and therefore rolled up into the value of your units.

The Sub-Fund launched on 31 May 2018. The Share Class launched on 27 July 2021.

The currency of the Fund is JPY, the currency of this product is USD.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator





The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.
